TERMS AND CONDITIONS

1. All animals to be fully immunised. Cats F3, Dogs C5.
2. All cats to be desexed. (Kittens excepted.)
3. If veterinary attention is required, owners are liable for all expenses. In the event of serious illness and the owner cannot be contacted the veterinary surgeons decision will be final.
4. Animals not collected within 7 days of the nominated date will be disposed of at Meadowmist Boarding Kennels and Cattery's discretion. All monies owing, including fees and costs relating to disposal, shall be payable by the owner forthwith after receipt of Meadowmist Boarding Kennels and Cattery's advice as to the amount thereof. If the costs are not paid as provided above, legal proceedings will be instituted without further notice.
5. If animals are boarded for more than 2 weeks, 50% of board must be paid in advance.
6. Meadowmist Boarding Kennels and Cattery reserve the right to refuse any animal and no reason shall be given.
7. Meadowmist Boarding Kennels and Cattery will not be responsible for any damage or injuries caused to any of the animals staying at their kennels other than as a result of the wilful or negligent acts or omissions by Meadowmist Boarding Kennels and Cattery or it's employees.
8. The full booked period will be charged in the holiday period.
9. Boarding rates are charged on calendar day basis.
10. A deposit as set by Meadowmist Boarding Kennels and Cattery is payable for each and every animal booked. Refunds are only available if notice of cancellation is given at least 4 weeks prior to the booked dates. Christmas deposits are non-refundable. An administration fee will be deducted from the returned deposit if the deposit is returned by mail.
11. The owner acknowledges that the signing of this contract shall create a lien over the animal in favour of Meadowmist Boarding Kennels and Cattery, which lien shall continue to exist while ever monies are owing pursuant to the contract.
12. Over the peak periods (Christmas, Easter & School Holidays), dogs will be charged at \$2 per day extra, cats at \$1 per day extra.
13. During the Christmas period a 10 day minimum will apply.
